Refunds:

Full refund if scratch is received by closing date less \$20.00 office fee.

No refunds after closing date or after start of competition -This includes classes canceled due to severe weather or other emergency conditions.

Bounced Check Policy:

\$30 fee; Entry wait-listed until cashier's check received.

Post Entries:

Will be placed on a waiting list to fill scratches. All "No Shows" that have not contacted the show office prior to first ride will be considered a scratch for the show and time slots may be filled.

Guest Horses:

Must send in a completed entry form with a \$35 guest horse fee plus the \$20 office fee, submit a current coggins, and pay either stabling or day parking.

Music for Freestyles:

Must be on cassette tapes or CDs provided by the competitor to announcer at least two hours prior to the start of the freestyle class.

Awards:

- ▶ **Trophy** (in classes of 3 or more) and 6 ribbons.
- ▶ **Dressage Seat Equitation** – Special prizes
- ▶ **High Score Prizes** per level/division as entries warrant.
- ▶ **USDF/Dover AA Medal** – see www.usdf.org for details.
- ▶ **NCDCTA Pro-Am Team Challenge Trophies** for all members of 1st through 6th placing teams
- ▶ **The Trainers Award** - will be presented to the trainer with the highest average dressage scores of the show. Both trainer's scores and those of his/her students will count towards this calculation. A trainer must have at least two students competing in the show to qualify. To be eligible for this award, the trainer must sign up for this award on the sheet provided in the show office prior to the first of the qualifying rides. The trainer must list on the application form each student whose scores will count toward this award. Details of the award and sign-up sheet are posted in the show office. The winner will receive a special award.
- ▶ **Freestyle Awards** – Special prizes for top 3 placings (Classes 171, 172, 271, 272, 283 and 284 combined)
- ▶ **NCDCTA Freestyle Award** – perpetual trophy awarded to the NCDCTA horse/rider combination, participating in the annual NCDCTA Horse of the Year Awards, receiving the highest percentage score for a USDF First-Fourth Level freestyle at the show.

Times:

2 Bags of shavings are included with horse stall (Excludes Tack). PLEASE PRE-ORDER EXTRA BEDDING PRIOR TO ARRIVAL..

Accommodations:

Host Hotel is Ramada Inn/Blue Ridge (919-832-4100). Must mention 'Horse Show' to receive special rate. 82.00 for King and 84.00 for Double.

Directions:

From I-440 (Beltline) in Raleigh, Hillsborough St. (NC54) exit toward Cary/Chapel Hill. Turn right at stoplight onto Blue Ridge Road. Take the first left onto Trinity Road. Horse Complex is on the left. Enter gate H-3 across from Carter-Finley Stadium.

From I-40 West, take Wade Ave exit. Exit right on ramp to Edwards Mill Rd and turn right. Turn left onto Trinity Road. Horse Complex will be on the right.

Arenas:

One indoor with spectator seating and one covered 20x60 arena with composite footing. Three outdoor 20x60 competition arenas with composite footing. Two sand warm-up rings. No one on foot is allowed in the warm-up area—coaching must be done from the side. All arenas will be open for schooling on Thursday until 8pm. Friday and Saturday, schooling in the arenas will be allowed after the last ride and until 8 pm.

Hospitality:

Food available on the grounds during breakfast and lunch hours. Free competitor party Saturday PM.

ENTRY DOCUMENTATION REQUIREMENTS

- Current USEF membership (or n/m fees) for Rider, Owner and Trainer, Coach
- Current USDF membership (or n/m fees, number) for Rider and Owner. **Rider's USDF membership may be either Participating or Group, Owner's USDF membership may be Participating, Group or Business; if Rider/Owner's USDF # is a non member ID #, the USDF non-member fee must be paid.**
- USDF Horse ID.
- Current (1 Yr) negative coggins.
- For Adult Amateur classes - USEF membership card must declare Amateur, or include \$30 amateur nonmember declaration fee.
- Juniors and Young Riders must include birthdate.
- Freestyle entries - copy of a 60% + at the highest test of the MFS level or higher.

FOR GAIG / USDF QUALIFYING CLASSES ALSO INCLUDE:

- Check "Qualifying" and add \$10 per Qualifying class.
- Copies of USEF and USDF Horse Registrations (not HID #s).
- Rider must have current Participating USDF membership; Owner must have current Participating or Business USDF membership.
- Rider, Owner, Trainer and Coach must have current USEF membership.

ALL ENTRIES must have THREE signatures - Rider, Owner and Trainer. Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. (Parents who sign as trainer are exempt from membership requirements).

NCDCTA Pro-Am Team Challenge Information

Eligibility: One Professional plus two-three Amateurs, Juniors and/or Young Riders make up a Pro-Am Team. Any level may be ridden; levels may be combined. The 3 highest scores will be averaged to find the Team Score from the Saturday Rides of all Team Members. (Intro, MFS and DSE scores will not be included) Team members (Professionals, Amateurs, Juniors and Young Riders) are considered as a horse/rider combination – if a rider has more than one horse entered in the competition that rider can ride on more than one team – the Pro-Am fee must be paid for each team and each team must have unique horse/rider combinations. *All Team members must be current NCDCTA members. AA Status is per NCDCTA rules for the Challenge.*

Awards: Trophy for all members of 1st through 6th placing Teams. All Team Members must be present at the Saturday Night Awards Ceremony to receive prizes.

Entries: Teams must be named with all team members indicated and all fees paid (\$20/team) by 9am Saturday. Competitors may indicate intention to compete on entry form ('other fee' section) or may sign up in show office.

NCDCTA is sponsoring the Pro-Am Team Challenge as a year-long team competition. Teams and their standings throughout the year will be recognized on the NCDCTA website (www.ncdcta.org). The top scoring teams will receive end of the year prizes. Other prizes may also be awarded. Each team from each show will be considered in the year-long standings. Teams may stick together throughout the year or may re-form from show to show. See www.ncdcta.org for more details.

FOR ANY DRESSAGE SHOW HELD WITH THE SERVICES OF EQUESTRIAN SECRETARIAL SERVICES:

Ensure that all (rider/handler, owner, trainer, horse, coach) USDF and USEF memberships and registrations are **complete and current** in the respective on-line databases, enter all numbers accurately on your entry form, and SEND NO DOCUMENTATION WHATSOEVER.

If your memberships and/or registrations are **not** current in the USDF and USEF on-line databases, send documentation proof with your "first of the year" entry. For each subsequent entry in the competition year, SEND NO DOCUMENTATION WHATSOEVER.

Be SURE to include a CURRENT and LEGIBLE email address with your entry! Equestrian Secretarial Services will check your memberships and registrations on-line with both USEF and USDF. If you are lacking, you will receive notification via email. Coggins and signatures (3) are still required to be sent with your entry.

ON-LINE ENTRIES:

Visit www.EquestrianSecretarialServices.com or link from www.ogs-horsesport.com to enter on-line and pay via PayPal / major credit card. You do NOT need a PayPal account to use this service! You will choose the show you wish to enter and will be required to enter the class number(s) you wish to ride and the stabling you need. Your fees will be totaled automatically. You will click the "Pay via PayPal" button to pay for your entry. You will have the opportunity to print your completed entry for your records and will receive an automated email receipt.

You will be required to submit your negative coggins (and, if applicable, your MFS documentation) at check-in. You will also be required to provide all signatures (rider, owner, trainer and – if applicable – parent or legal guardian and coach) at check-in.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.


Federation Entry Agreement



By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.
